2. The main objects and propose of the Trust shall be :

- ii) To prepare a project based on necessary research in collaboration with it professional who have developed such model/ Training centers in India and elsewhere.
- iii) To prepare course content requiring full time attendance leading to a credited qualification making specific packages to cater for sectarian need by adding special modules.
- iv) To enhance employability provide help for the youth to grow in English language skill by allowing simultaneous use of their native language and computer Training etc. etc.
- v) To use popular free open source software via the computer labs and have adopted the system of Technology and method Training to specific opportunities and limitations.
- vi) In order to make the programme affordable, reduce the cost of Hardware and Software institution to a third that of conventional approaches.
- Vii) To enhance possibility of placement adopt methodology of course construction by close participation with the potential employees.
- viii) To monitor and maintain the standard of Program to be affiliated with professional bodies under the leadership of the central authorities (such as Ministerial authorities central and state Govt. also).
- ix) . In the context of experience in training the rural youth, be open to the opportunities of other vocational programme relevant to the

- xi) To impart and spread education in Arts, literature, science, commerce, Engineering, Technical, Medical and all another fields of education (even all other vocational and Training institute i.e. Teacher Training College, B.Ed. College and other Training Centre) to the subject of the Govt. of India, Govt. of W.B. and the countries abroad.
- xii) For the purpose as aforesaid to found, maintain, organize, run, manage, supervise, co-ordinate, affiliate, control, guide and aid schools, colleges Training Institute (including Teachers Training College), University, Hostels, Boarding houses, Laboratories, libraries, Exhibitions, Practical classes, awareness camp and obtain affiliation with Indian/ foreign University or Universities.
- xiii) To grant stipends, scholarship, and allowances or gratuities to the deserving students and candidates.
- xiv) To hold examination and to grant certificate or other academic distinctions or title to persons who have complied with the conditions laid down in the regulations or bye laws of the Trust/ or the State/ Central Govt. or any other Statutory body set up by such Govt.
- xv) For the said purpose to arrange for and take all necessary steps as may be required including arranging for admission to Educational Institutions and if possible stay at these.

- vi) To institute, conduct, defend or compromise legal proceedings by or against the Trust or its employees in regard to any matters affecting the Trust directly or indirectly.
 - vii) To extend, vary or amend any of the provisions hereof.
 - viii) To do all such other lawful thing as are conducive or incidental to the attainment of any of the above objects and for furthering the growth of the Trust or its resources.
4. That the Trust shall be named and known as "BULBUL CHANDI EDUCATION AND SOCIAL WELFARE TRUST", which will function as a nonprofit and non political organization and utilize all the recourses generated or received lonely for the object of the Trust.
 5. The Trust shall not participate in or intervene in any political campaign.
 6. The income and property of the Trust will be applied for the promotion of the objects of the Trust, as set forth herein before and also any other thing related to education and no portion thereof shall be paid dividends, bonuses or otherwise whatsoever by way of profit to any person.

 - i) True accounts shall be kept of all sums of money received and spent by the Trust and the matter in respect of which such receipts and expenditure take place and credits and liabilities of the Trust. The account of Trust shall maintain regularly.
 - ji) To operate the Bank A/C, the Trustee Board must select at least three out of five authorized signatories including the chairperson, the secretary and the Treasurer or any Trustee.

 - (a) The Trust and the management thereof shall vest in the Board of Trustee and there shall be not less than 2 (two) not more than 10

(ten) Trustees of the Trust The parties hereto have been nominated and appointed Trustees shall appoint a Chairperson, a Secretary and a Treasurer and be entitled to terminate his employment A trustee may retire at any time by giving one month's notice in writing to the other trustees of his desire to retire. The office of a Trustee shall be vacated if he shall become of unsound mind or shall be charges with an offence involving moral turpitude or attain the age of 65 or absent himself from three consecutive meetings of the Board of Trustees without leave of absence from the Board.

(b) In the case of death or voluntary retirement of any trustee the selected person of retired or deceased trustees should be appointed as new member.

10. The general management and control of the trust for the purpose of managing the trust affairs and properties and carrying out the object of the Trust aforesaid shall be vested in the Trustee and without prejudice to the generality of the objects and powers mentioned as aforesaid, they shall have the power to do all or any of the following things, that is to say

a) To enter into agreement, memorandum of understanding etc. with any Educational Institution or University where in India or a board for imparting education to intending persons.

b) To enter into contract and borrow money for the purpose of the trust and managed of its prosperities and asset.

c) To appoint Officer and servants at such remuneration as they may deem fit

d) To receive grants, donations and subscription.

- e) To give donation, subscription, and grants to the organizations or Institutions working in the field of education.
- f) To make such rules and regulations from time to time for the management and conduct of the affairs of the Trust and its properties and assets.
11. The trustees will also have the following powers.
- a) To apply the whole or part of the income of accumulation thereof or part of the corpus of the trust properties for one or more of the objects of the Trust as the trustees may determine from time to time.
- b) To help, contribute, promote, take over or amalgamate with any other society, Trust, Body or Institution whether incorporated or not for the object similar to those of the Trust herein.
- c) To declare and give bonus, gratuities or allowances to such persons who may be employees of the Trust or the families or dependents of such persons as may be decided by the Trustees and/or authorized under law or Income Tax Act 1961, or the statutory modifications thereof.
- d) To accumulate the corpus and/or the balance of the income of the Trust properties after meeting all the expenses of the trust and/or institutions with liberty to the trustees to spend such a accumulation of balance income for establishment and running of educational institutions and carrying out of the aforesaid objects or incidental hereto.
- e) To invest and keep invested the trust properties either by purchase or obtaining long terms lease of immovable properties or in shares, debentures, or other securities or any business undertaking and investments whether authorized by the Indian Trust Act or not and to alter, vary to transpose such investment from time to time as the

- f) To sell, dispose of, alienate or otherwise deal with any property movable or immovable comprising the trust fund and utilize the sale proceeds or the amount to receive for the purpose and object of the trust.
- g) To let out, demise any immovable property comprised in the Trust fund or belonging to the Trust for such period and at such rent and on such terms and condition as the Trustees in their absolute discretion may deem fit.
- h) To open account with any Bank of Banks, to operate such accounts and to give instruction to provide for opening and operation of such accounts by one or more of trustees or by one or more agents as may be appointed by the Trustees.
- i) To institute, adjust settle, compromise, compound refer to arbitration, all action, suits, claims, demands and proceedings regarding the Trust properties or any matter relating to or touching or concerning the Trust.
- j) To appoint Constituted Attorney or Agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and to appoint other or other in his their stead and place.
- k) To appoint or make provisions for the appointment of any person (Including all or any of the Trustees) as Committee or Administrator or Managing Trustee of otherwise for the purpose of the Administration of the Trust in such manner and subject to such rules and regulations as the Trustees may prescribe and also appoint or provide for the appointment of separate trustees to hold any property or any fund or investments subject to the Trust of this deed in such

- b) The receipt or a person authorized by the Trustees or resolution of the Board of Trustees for any money paid or any property transferred or delivered to the Trustees in execution or pay of the Trust or powers hereof or for the purchase moneys of any property authorized

14. The Trustees will not be entitled to receive any remuneration as trusted but may reimburse themselves of all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
15. The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and regulating the meeting of Trustees in the absence of such regulations.
 - a) All matters will be decided by majority and five (5) trustees shall from a quorum for meeting to Trustees in presence of Settler or Chairperson.
 - b) Resolutions passes without any meeting of the Trustees and evidenced in writing under the hands of three-fourth of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the Trustees in presence of Settler or chairperson.
16. Without permission and discussion of Settler or Chairperson and Secretary no meeting, decision, resolution can be done.
17. The Board of Trustees may appoint sub-committees of Trustees for such purposes and with such powers as the Board may kind fir with due permission of the Chairperson.
18. The Board of Trustees may delegate any of its powers to such persons as they may deem appropriate.
19. The Board of Trustees may at a meeting specifically convened for the purpose agree that the Trust shall be dissolved Upon dissolution should there remain any property whatsoever after satisfaction of debts and liabilities.
20. All the trustees unanimously shall however be entitled to modification and alteration of this deed.

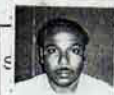
